

Thursday, 20th - Sunday, 23rd August, 2009

Held every two years, the Moscow Air Show (MAKS) is a very popular event for both Russians and aviation enthusiasts everywhere, not least because the organisers usually produce at least one surprise: for example, the first public showing of a new aircraft, or unique flying combinations in the air display.

We visit on a Trade Day and a Public Day, and with our VIP tickets we can park on the airfield itself rather than having to use the park and ride scheme from Bykovo.

If it's still open, you may also see the remaining aircraft in the collection at Khyodinka.



We also go see the Hawker Hurricane IIB recently restored by Patrioticheskoe Vysota in St Petersburg, and now on display in the Krasnogorsky Museum of Techniques in Moscow.

If you prefer to spend Friday at MAKS and Saturday looking around one of the finest aviation collections in the world, the mind-boggling Russian Air Force Museum at Monino, this may be possible: please ask for details. This visit would be done by car with a local English-speaking guide: it is not included in the tour price. Website: www.moninoaviation.com

We fly on the scheduled services of British Midland Airways from London's Heathrow Airport; transfers and transportation is by deluxe, air-conditioned coach; and we stay 3-nights at the 4-star Aerostar Hotel. Opened last July, it is located in Khodynka and only 3kms from Red Square: a 15-minutes walk or short taxi ride away. Website: www.aerostar.ru

In addition to an Ian Allan tour manager, we are also accompanied at all times by a local English-speaking guide.

PROVISIONAL ITINERARY (all times local)

DAY 1: Thursday, 20th August

Between 06:30 and 07:30 hrs. please check-in with British Midland Airways on the "Departures" level (first floor) of Terminal 1 at London's Heathrow Airport. Then meet your Ian Allan Tour Manager who will be stood by the entrance through to "International Departures". This is the busiest time of the day in Terminal 1 so please allow plenty of time to check-in.

After Immigration, Baggage Reclaim and Customs we enter the Arrivals Hall and meet our local English-speaking Russian guide; we then transfer by private coach to the Aerostar Hotel in Moscow suburb of Khodynka. Payment for Ian Allan Aviation Tours

A deposit of £250.00 per person per tour should accompany your Booking Form, with the balance due 10 weeks prior to the tour's departure. Please see your Booking Confirmation/Invoice for the exact date. Please note that a reminder of the payment date will not be sent.

Passports and Visas

Citizens of the UK are required to be in possession of a Full UK Passport, which must be valid for at least 6 months from the expiry date of your Russian tourist visa. You may also refer to the World Travel Guide website: www.wtgonline.com for general information on passports, visas and health requirements.

Everyone requires a visa to enter Russia and the price varies according to how quickly you want your application processed. For UK Passport holders/residents, the cheapest rate for a single-entry tourist visa is currently £50.00 based on a processing time of 5 working days; however, during the summer months it can take up to 21 days to process such applications! The above information is current but is subject to change without notice.

All visa applications have been outsourced by the Russian Consular (Visa) Section to a private company, and there is now an additional "Consular Admin Fee" of £22.00, taking the current price of a Tourist Visa to £72.00.

For UK Passport holders/residents we strongly recommend you use "ASLA Select" to get your visa, as they will ensure that all the necessary supporting documentation is in order and included with your application; and they usually can get visas more quickly than the advertised time. In addition to the cost of the visa and the Consular Fee, ASLA charge a fee of £35.00 for what is a very reliable service (therefore total = £107.00).

You will also need to include with your application proof of travel insurance.

Full details, including a visa application form, a "Letter of Invitation" from the Russian Ministry of Foreign Affairs, and a tourist voucher, will be sent to you nearer the date of travel.

Please note that you cannot apply for a tourist visa more than 3 months in advance of your date of travel.

Foreign & Commonwealth Office (FCO) Consular Advice

The FCO's consular service is a major operation. Every hour of every day consular staff around the world are advising and helping British nationals. For up-to-date passport, visa and security information on the destination you intend visiting, we suggest you visit www.fco.gov.uk/knowbeforeyougo

In addition, the Association of British Travel Agents (ABTA) provide an Information Line, telephone: 0901 201 505 (calls currently charged at 50p per minute).

Baggage Regulations – British Midland Airways (BMI) – London Heathrow Departures only

BMI's baggage rules, for Economy Class allow an unlimited number of pieces in the aircraft's hold, up to a maximum weight (when totalled) of 20kgs per person.

Hand, or cabin, baggage is limited to one item no bigger than 25cm (9.85 inches) deep x 56cm (22 inches) long x 45cm (17½ inches) high, which you must be able to lift unaided into the overhead locker onboard the aircraft, plus one 'personal item', i.e. laptop, briefcase, etc..

Limited quantities of liquids (individual containers must not exceed 100ml or 3.5 fl oz), are now allowed as hand baggage but must be carried separately through security in a clear plastic, zip-top or re-sealable bag that does not exceed 20cm x 20cm (8 inches x 8 inches), or quart size. Items must fit in the bag comfortably and the bag must be completely closed.

The bag can only contain liquids such as shampoo, suntan lotions, creams, toothpaste, hair gel and hair spray, perfumes, cosmetics such as mascara and lip gloss, water and other drinks, soups and syrups and other items of a similar consistency.

Cigarette lighters are NOT permitted in hold baggage or through the security search. These may be purchased airside.

Hand baggage can also include electronic equipment such as mobile phones, digital cameras and MP3 players (such as i-Pods). Laptops must be removed from the bag for x-ray.

Prescription medicines in liquid form, e.g. diabetic kit can also be included.

At security all remaining items should be placed in the tray provided for screening, e.g. car keys and fobs, cash, solid food, books, newspapers, cigarettes and tobacco, belts and shoes. Pushchairs and walking aids are permitted but must be x-ray screened. All wheelchairs will be subject to search. Please note: you may be subject to a hand search by the security team and required to remove footwear to be x-ray screened.

If flying from any other airport on BMI, i.e. on connecting services to/from Heathrow, the allowance differs depending on the airport – please ask for details at time of booking or contact your local BMI office or airport for details.

Meals

This tour is on a Full Board basis; breakfast, lunch and dinner each day (lunches will be of the packed variety).

Health Requirements

There are no known mandatory or recommended precautions for visiting Russia; however, we strongly recommend you consult your local doctor or health centre for the latest information.

Climate and Dress

Moscow in August should be hot and sunny (low - mid 80s°F), so we recommend casual, but smart, summer attire.

Travel Insurance

For citizens of the United Kingdom, Ian Allan Travel Ltd can provide competitive and comprehensive insurance cover for the duration of your tour. However, if you do not wish to take out our insurance, you must ensure that comparable or greater cover is taken. The number of your Insurance Policy should be written, if known, on your Booking Form at the time of making the reservation, but no later than the date when final payment is due. A copy of the policy must be forwarded to Ian Allan Travel Ltd.

Individual insurance policies are arranged through CoverMore Insurance Services Limited; the premiums for which will vary according to your circumstances. Full details are available on request.

Wheelchair Assistance at Airports.

Anyone requiring wheelchair assistance at airports must have this service requested and confirmed in advance. Airlines and/or airports can no longer provide this service without prior confirmation, therefore, please annotate your booking form accordingly.

Flexible Itinerary

We are very happy for enthusiasts to take time away from the printed itinerary to pursue their own interests during multi-day stays in the same place, so long as they inform the Tour Manager. It will be the individual's responsibility to ensure that they re-join the group in the hotel at the stated time on the day of departure.

Land Only Price

For enthusiasts who would prefer to join the tour in Moscow (instead of flying from the UK with the main group), we are very pleased to provide a 'Land Only' price.

This price *does not* include international flights to/from Moscow at the start and end of the tour.

You are strongly advised to contact us before making your own flight arrangements to/from Moscow in the event that there has been a change to the published itinerary.

Please note that the 'Land Only' price is based on you joining the tour at the Aerostar Hotel; it does not include either arrival nor departure airport transfers, however, should your arrival/departure coincide with that of the group, a seat will be offered when available for an appropriate supplement.
